



## SRI LANKA RUPAVAHINI (TV) CORPORATION

### INVITATION OF EXPRESSION OF INTEREST (EOI) TO PROVIDE LOCAL AND FOREIGN FILMS FOR BROADCASTING BY THE SRI LANKA RUPAVAHINI CORPORATION - EOI NO: 93 / 2025.12.26

Expressions of interest (EOI) are invited from local and foreign suppliers in order to provide local and foreign films for broadcasting by the Sri Lanka Rupavahini (TV) Corporation (SLRC).

**Experienced film suppliers , interested in collaborating with SLRC for a period of one (1) year , are required to submit their expression of interests (EOIs) including the following details .**

01. Detailed company profile and registration certificates
02. Details and profile of company's staff and consultants and their experience
03. Comprehensive catalogue of Sinhala and foreign films in your possession including category of the film , language , local or foreign film , color or black/white etc.
04. Pricing structure and payment terms
05. Proof of ownership / broadcasting rights for films
06. Details on technical specifications and quality assurance process of films

#### **Eligible suppliers should have ;**

01. The supplier must be a **locally or internationally registered company, a sole proprietorship or a properly registered individual** and must be verified through the relevant registration documents.
02. The supplier must verify **ownership and broadcasting rights of the films** in his possession through legal documentations and the films provided for broadcasting must be free from any legal ownership claims, restrictions or liabilities.
03. Films must be supplied for broadcasting for **a period of one year**.
04. Supplier must provide comprehensive catalogue of Sinhala and foreign films in his possession including **category of film , language, local or foreign film , color or black/white , pricing structure and payment terms** etc.
05. The Sri Lanka Rupavahini Corporation **reserves the fully right to remove and broadcast any scenes deemed unsuitable for transmission**.
06. The supplier must provide the films at a technical quality suitable for broadcasting and they will be **aired only after the quality has been inspected and approved**.
07. Suppliers must **ensure that the Sinhala subtitles are provided for all foreign films**.
08. The Sri Lanka Rupavahini corporation **reserves the fully right to cancel , amend or withdraw of the invitation at any time**.
09. After evaluating the applications , suitable suppliers will be selected. **The decision of Sri Lamka Rupavahini Corporation shall be final and binding**. Objections for the decision are not entertained.
10. The Sri Lanka Rupavahini Corporation will **enter into a contract agreement** with the selected party.

Eligible and interest suppliers should send their EOI, so as to reach **Chairman, Procurement Committee, Sri Lanka Rupavahini Corporation, Independence Square, Colombo 07, Sri Lanka or deposit in the tender box kept at Finance Division of this corporation on or before 3.00 p.m. on 26.12.2025.** Further, please note that "EOI" should be submitted in a sealed cover marked as "**EOI to provide local and foreign films for broadcasting by Sri Lanka Rupavahini Corporation -EOI No: 93 /2025.12.26**" on the left hand top corner of the cover.
